At any time after filing a protest, but no later than fifteen (15) days after the date award or notification of intent to award, a protestant may amend a protest that was first submitted within the ten (10) day time limit. A protest shall be writing, shall set forth the grounds of the protest and the relief requested with enough particularity to give notice of the issues to be decided, and must be received by the Contract Officer within the time provided. Procurement and Contract Administration, Article IV, Section.**
